CERTIFICATION ORDER

This matter came on for consideration before the State Labor Relations Board on August 9, 1973.

1. Based upon the petition, answer and other pleadings filed by the parties the Board ordered an election to be held to determine whether or not the above described employees of Green Mountain Racing Corporation, desired to rescind the authority of International Brotherhood of Teamsters, Chauffeurs, Warehousemen and Helpers of America Local Union No. 597 to be their exclusive collective bargaining representative.

2. On August 4, 1973 an election was conducted by a representative of the Board by secret ballot.

3. One hundred forty-eight employees were eligible to vote and were asked to vote on the following question:

Do you wish to rescind (terminate) the authority of Local Union No. 597 of Vermont (an affiliate of the International Brotherhood of Teamsters, Chauffeurs, Warehousemen and Helpers of America) to act as exclusive bargaining agent for the Money Counters and Mutual Department Employees of the Green Mountain Racing Corporation

Seventy-six employees voted all in favor of rescinding the authority of Local Union No. 597 of the International Brotherhood of Teamsters, Chauffeurs, Warehousemen and Helpers of America.

NOW THEREFORE it is hereby ORDERED that Local No. 597 of the International Brotherhood of Teamsters, Chauffeurs, Warehousemen and Helpers of America, is hereby decertified as the exclusive collective bargaining representative of the Money Counters and Mutual Department Employees of the Green Mountain Racing Corporation. Effective this date Green Mountain Racing Corporation shall not recognize the International Brotherhood of Teamsters, Chauffeurs, Warehousemen and Helpers of America Local No. 597 as the exclusive collective bargaining representative of the Money Counters and Mutual Department Employees of the Green Mountain Racing Corporation. The said Local and Parent Union shall henceforth make no claim of being the exclusive collective bargaining representative of said employees.
